Free Christmas Tree & Light Recycling

Don't throw away your Christmas tree or string lights; give them another life by recycling! The City of Centennial, Arapahoe Park and Recreation District and South Suburban Parks and Recreation District are providing residents with an opportunity to dispose of Christmas trees and unwanted string lights appropriately and safely. Starting Tuesday, December 26 through Monday, January 15, 2024, you can dispose of clean, non-ornamented, non-decorated Christmas trees and string lights seven days a week from sunrise to sunset at the Centennial locations listed below. Lights must be removed from trees and wreaths to recycle and artificial trees will not be accepted.

Unwanted string lights may be dropped off at the following locations:

- Piney Creek Hollow Park, 6140 S. Tower Road
- Centennial Civic Center, 13133 E. Arapahoe Road
- City's Eagle Street Facility, 7272 S. Eagle Street

It is anticipated free mulch will be available for private use, on a first come first serve basis, at Lookout Park and Piney Creek Hollow Park starting Thursday, December 28 and every other day after that, excluding holidays, weekends and snow events.

Entities Operating Within Foxridge

There are several separate and independent entities that operate within our community. Below is a list to help you better understand how these entities relate to the Foxridge Improvement Association.

THE FIA (Member Funded)

The Foxridge Improvement Association (FIA) is a non-profit corporation with membership available to all 934 homeowners in Foxridge, but is not mandatory. The purposes of the FIA as stated in the Articles of Incorporation Article 5 are "To educate and inform Owners about the Covenants applicable to the various Filings, the betterment of the general welfare and the promotion of friendly relations between the residents of Foxridge, and, when called upon, to provide arbitration of disputes related to Community issues." The annual voluntary FIA dues are \$60.00 per calendar year (Jan 1 thru Dec 31).

FGID (Taxpayer Funded)

The Foxridge General Improvement District (FGID) is not a part of the FIA. The FGID is a taxing district approved by the Foxridge homeowners in 1990 to provide funding for items such as community fencing, entry gardens and monuments, irrigation, and landscape maintenance. In 2019, voters living in Foxridge approved a mill levy increase to pay for the installation of a new Trex fence along Quebec and the main thoroughfare streets. The fence project was completed in 2021. The FGID funds are administered by the City of Centennial via Foxridge Community representatives who are approved by the FGID Board of Directors (City Council).

CenCON (Funded by Association Members)

Centennial Council of Neighborhood (CenCON) is composed of neighborhood associations' representatives in the City of Centennial. Their current membership represents about 22,000 Centennial homes in about 50 different Homeowner Associations. CenCON meets eleven times a year to impart important information from the City and many special districts that serve its members. An FIA Board Member serves as the FIA's CenCON representative and relays this information back for dissemination to homeowners by means of monthly meetings, newsletters, etc.

SSPRD (Taxpayer Funded)

South Suburban Parks and Recreation District (SSPRD) manages and maintains the public tennis courts, parks, trails, Foxridge Orchard, some grassed and irrigated street rights-of-way and the natural open space drainages within Foxridge. The mission of the South Suburban Park and Recreation District is to foster healthy living through stewardship of the environment, parks, trails, and open space and by providing recreational services and programs.

THE CLUB AT FOXRIDGE (Foxridge Swim and Racquet Club) (Member Funded)

The Club at Foxridge is a member-owned private swim & tennis club located one block west of Quebec on East Mineral Avenue at 7070 E Mineral Ave, in the Foxridge neighborhood. Joining The Club at Foxridge is not mandatory and membership is also available to those living outside of Foxridge. It is not affiliated with the FIA or FGID, although a mutually beneficial cooperative relationship is maintained. The Club offers a swim team program and lessons that are open to non-members at a higher fee. A 2023 revitalization project updated the pool and amenities and a project is underway to redevelop the dilapidated tennis court area to include tennis, pickleball and a social area.



The garden is just east of the swim club at 7070 E Mineral Ave. It is affiliated with Denver Urban Gardens and is managed solely by volunteers with a mutually beneficial and cooperative relationship with the FIA and the swim club.





Instant Pot (Pressure Cooker) **Beef Stew**

Craving comfort in bowl? Pressure cook this simple, hearty, and Whole30-friendly Instant Pot beef stew!

Ingredients:

- 3 pounds beef chuck roast or boneless short ribs or beef brisket cut into 1½- to 2-inch cubes
- Kosher salt or Magic Mushroom Powder
- 1 tablespoon ghee avocado oil, or fat of choice
- 2 medium onions thinly sliced
- 1 pound cremini mushrooms cleaned, stemmed, and quartered
- 2 tablespoons tomato paste
- 6 garlic cloves peeled and smashed
- 2 tablespoons coconut aminos or gluten-free tamari if you tolerate fermented soy
- 1 teaspoon fish sauce
- 2 fresh thyme sprigs or 1 teaspoon dried thyme
- 1 dried bay leaf
- freshly ground black pepper
- ¼ cup Italian parsley roughly chopped

OPTIONAL ADD-INS:

- 3 large carrots cut into 1-inch pieces
- 1 pound Yukon Gold or Russet potatoes cut into 1-inch cubes

Directions:

- In a large bowl, toss the cubed beef with 1½ teaspoons of Diamond Crystal kosher salt. (Psst! You can use Magic Mushroom Powder in place of salt and it will taste umami-riffic!)
- 2. Press the "Sauté" button on your Instant Pot and when the metal insert is hot, add your preferred cooking fat. Once the fat's melted, add the onions and mushrooms and a ½ teaspoon kosher salt. Sauté until the onions are softened, about 5 minutes. (If you're using a stovetop pressure cooker, melt the fat over medium heat and sauté the onions and mushrooms.)
- 3. Stir in the tomato paste and garlic, and cook for 30 seconds or until fragrant.
- 4. Toss in the salted beef, coconut aminos, fish sauce, thyme, and bay leaf. Give everything a good stir to combine all the ingredients. (You don't need to add any extra liquid to the Instant Pot because the onions and beef will release sufficient liquid. However, if you're using an older stovetop pressure cooker, you may need to add ½ cup of broth or water.)
- 5. Press the "Keep Warm/Cancel" button on the Instant Pot and cover and lock the lid. Next, program the Instant Pot to cook for 35 minutes under high pressure. Once the pot is programmed, walk away. (If you're using a stovetop pressure cooker, you won't have all those buttons to press. Just cook on high heat until high pressure is reached. Then, reduce the heat to low to maintain high pressure for about 30 minutes.)
- 6. When the stew is finished cooking, the Instant Pot will switch automatically to a "Keep Warm" mode. If you're using a stovetop pressure cooker instead, remove the pot from the heat. In either case, let the pressure release naturally (about 15 minutes). If the pressure hasn't released completely after 15 minutes and you're impatient, you can manually release the pressure by turning the valve at the top to venting.
- Fish out the thyme and bay leaf, and check that the meat is fork tender. If not, cook for another 10 minutes under high pressure. Season to taste with salt and freshly ground black pepper.
- 8. If you're eating the stew right away, you can skim the fat off the top of the stew. Ladle out the stew, and adorn with some chopped Italian parsley.
- Adding root veggies to your beef stew? Stir in the carrots and cubed potatoes into the cooked stew and pressure cook everything for 5 minutes under high pressure. Manually release the pressure, stir, and adjust for seasoning before serving.

Natural Neighbors: Junco – Snowbirds

- Juncos nest in the far north and migrate south, including our area, for milder winter weather; thus the name snowbird as they foretell the coming of cold weather for us.
- They are our most common bird feeder visitor in winter, preferring hulled sunflower seeds and millet.
- Notice the flash of white of the outer tail feathers when one flies.
- One foraging technique, called "riding", is to land on a seed cluster of a grass stalk and ride it to the ground where they pick the seeds while standing on the stalk.

Here's some information that might interest you:


- Winter pruning: All trees can be pruned in the winter months, even though the leaves have fallen off. In fact there are some species of trees that should ONLY be pruned in the winter months while the tree is dormant. These species include: American elms, crabapple, apple, pear, and hawthorn to name a few. The reasons for this are to prevent the spread of elm scale on American elms and to eradicate fire blight on fruit trees.
- Dead or dying trees: While trees are aesthetically pleasing, add value to the environment and community, and help save on energy costs, they can also pose a serious threat to your property and your safety. Some trees can become susceptible to structural failure, pests, and disease for various reasons (this could easily become an entire book!). It is important to have your trees assessed by a professional to determine a plan of action to better care for your trees. When a tree is in decline, we can decide whether to fertilize and/or trim, cable/brace, treat, or remove based on a number of factors.

Helpful tips on when to call an arborist or consider removing a tree:

- 1. If a tree loses its leaves when it should have leaves and has no signs of growth, it will NOT come back. It may produce epicormic sprouts (suckers) at the base; this is a sign of stress.
- 2. It is safer and more cost-effective to remove a tree that is 40%-60% dead rather than wait until it is completely dead.
- 3. You notice a significant crack or break in a large branch or main stem of the tree.
- 4. The roots are cracking pavement or damaging your property.
- 5. There is a significant lean to the tree.
- 6. There are mushrooms growing on the stem or at or near the base of the tree.

Example of work:

Recently, we had a client who had invasive roots that caused tens of thousands of dollars in damage to their property. Due to the number of different trees in their backyard, we had to identify the culprit based on the roots. Once the hazard tree had been discovered, we then decided to remove the hazardous tree properly and safely to mitigate any further damage. We then gave recommendations for replanting a species that would not grow to be as invasive and would be more manageable in the future.
